## REGISTRATION & RELEASE, CONT.

**This is a Contract between The Boarding Bungalow, ("Facility") and the pet owner whose signature appears on the background statement attached hereto ("Owner").**

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Facility and accepts both our holiday and non-holiday cancellation policies. Non-holiday reservation cancellations must be made at least 2 full days prior to the date of the reservation to avoid first night fee. Holiday reservation cancellations must be made at least 5 full days prior to the date of the reservation to avoid first night fee and forfeit the \$50 non-refundable deposit. In addition, a "no show" will result in a \$25 fee in addition to current cancellation policy.

2. Owner agrees to pay a \$5.00 warranty fee per pet/per stay, which covers accident-related injuries that may occur while your pets are in our care. Facility will cover up to a maximum of \$500.00 of veterinary services per pet, if needed. Not covered under this warranty are pre-existing health conditions/injuries or two pets in the same suite, at the owners request, that injure each other.

3. Owner understands that check-out is anytime before 1:00pm or an additional half-day rate will apply.

4. Owner agrees that the pet shall not leave Facility until all charges are paid to Facility. All Charges incurred by Owner shall be payable upon pick up of pet. Facility shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Facility.

5. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs exceeding maximum warranty limit of \$500.00.

6. By signing this Contract and leaving pet with Facility, Owner certifies to the accuracy of all information given about said pet.

7. Facility shall exercise reasonable care for the pet delivered by Owner to Facility. It is expressly agreed by Owner and Facility that Facility's liability shall in no event exceed the lesser of the current chattel value of a pet of the same breed or the sum of \$500.00 per animal admitted.

8. Owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Facility, and assume any expense and liability for injury to any human or other animals or damage to facilities caused by the pet. This includes any medical costs incurred by Facility if your pet is approved for group play and injures another pet or human due to aggressive behavior.

9. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

10. Owner specifically represents to Facility that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this Agreement, Owner also agrees to notify Facility of any known exposure of pet to a communicable disease and hold pet out of attending Facility until pet is symptom free for a minimum of seven (7) days or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Facility policy.

11. Owner understands pets must be free of all fleas/ticks. If detected upon arrival or during stay, Capstar and a flea bath will be administered at owner's expense.

12. Owner consents to Facility using pet's likeness and waives all claims of compensation for use of such likeness by Facility.

13. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Facility, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. Owner gives consent to Facility to act on Owner's behalf in obtaining emergency veterinary care at Owners expense. Owner indemnifies and holds Facility and its employees harmless for said expenses.

14. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Facility.

15. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
